The definition of schools whose students are eligible to audition for the 2021 Wind Symphony has been established as Class A, B and C schools as defined by MHSAA. Please allow at least a week before the audition/application deadline.

- Students from these schools may audition for just the Wind Symphony by submitting the *Wind Symphony* audition.
- Students submitting the complete *Winds and Percussion* audition will be eligible for NafME All-Northwest Band and Orchestra consideration.
- Students submitting *BOTH* auditions are eligible to be considered for ALL instrumental groups (except jazz which requires separate materials) and assigned to the best group and position possible.
